A **Broker/Dealer** processes the commission business of Registered Representatives licensed with the firm and holds responsibility for responsibility for regulatory compliance and adherence to securities laws. A Registered Investment Advisor (RIA) processes the fee-based business of IARs licensed with the firm and holds responsibility for regulatory compliance and adherence to securities laws.
